

Camping Release, Waiver of Liability, and Indemnity Agreement

In consideration of being permitted to enter upon the property of Clear Springs Enterprises, LLC and Clear Springs Land Company, LLC, located in and around Bartow, Florida, (hereinafter "Premises"), and be allowed to camp at the Jeepin' with Sheriff Judd event, for good and valuable consideration, the undersigned ("Releasor(s)"), for himself/herself, his/her personal representatives, heirs and next of kin **HEREBY RELEASES** Polk Sheriff's Charities, Inc., Polk County Sheriff's Office, Polk County, the Polk County Board of County Commissioners, Grady Judd, as Sheriff of Polk County, a Constitutional Officer for the State of Florida, individually and in his official capacity, Clear Springs Farming, LLC, Clear Springs recreation, LLC, Clear Springs Enterprises, LLC, Clear Springs Land Company, LLC, Clear Springs Packing, LLC, Clear Springs Strawberries, LLC, and Clear Springs Farming, LLC, individually and in their official capacity, and all of their employees, appointees, agents, contractors, and sub-contractors, (collectively, "Releasees") from all claims, cause and causes of action, lawsuits, trespasses, damages, judgments, executions, liabilities, and demands of any kind whatsoever, in law or in equity, including any compensatory, consequential, incidental, or punitive damages, as well as any charges, expenses, attorney's fees or other costs incurred while on the premises.

IN ADDITION, the undersigned **AGREES TO INDEMNIFY AND HOLD HARMLESS** and defend the Releasees against any claim, loss, liability, damage or cost which each of them may incur due to the entry or presence, of Releasor(s) or his/her property, in or upon the Premises. Releasor(s) expressly agrees that this General Release is intended to be as broad and inclusive as permitted by law, and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect.

PARENTAL OR GUARDIAN CONSENT (applicable if person camping is under the age of 18). I hereby consent to my minor child camping on the property of Clear Springs Enterprises, LLC and Clear Springs Land Company, LLC as discussed herein.

SEVERABILITY: I agree that in the event any provision of this agreement is held or adjudicated to be contrary to any statute or law, or otherwise unenforceable, the remaining provisions of this document shall be enforceable to the fullest extent permitted by law.

GOVERNING LAW: This agreement shall be interpreted according to Florida law. It is to be construed as broadly and inclusively as is permitted by relevant Florida law.

I also hereby give my consent to Jeepin' with Sheriff Judd and any other media outlets to use photographs and video images in their publications and website of me as well any passengers, friends, family and minors under the age of 18. I acknowledge that since my participation in publications and websites produced by Jeepin' with Sheriff Judd and other media outlets is voluntary and neither the minor children, my passengers nor I will receive financial compensation.
